Whereas the impact on these youths will be even worse given Covid 19 and the mental health crises that are occurring for children at all ages as a result of the pandemic;

Whereas the schools, who are also struggling to deal with Covid 19, remote learning and safe in-classroom learning, will lose a critical resource for their students;

Whereas these funding cuts to the School Based Youth Services Programs throughout the State will disproportionately impact the minority populations in schools;

Now, therefore, be it resolved that the Warren Hills Regional Board of Education strongly opposes the defunding of the School Based Youth Services Programs;

And be it further resolved that funding for the School Based Youth Services Programs be restored immediately.
